

ENROLLED ORDINANCE NO. 17-005

AN ORDINANCE AMENDING TITLE 9 “PUBLIC PEACE, MORALS AND WELFARE”; CHAPTERS 9.04 “OFFENSES BY OR AGAINST PUBLIC OFFICERS AND GOVERNMENT” AND 9.08 “OFFENSES AGAINST PUBLIC PEACE AND DECENCY”; REPEALING SECTIONS 9.04.050 “HARRASS OR INTERFERE WITH ANY DOG USED BY THE POLICE DEPARTMENT”, 9.08.050 “UNLAWFUL TO ASSEMBLE”, 9.05.060 “UNLAWFUL TO COLLECT IN CROWDS”, 9.08.120 “SECRET STALLS, ETC – PROHIBITED IN CERTAIN ESTABLISHMENTS”, 9.08.170 “SOLICITATION OF FORNICATION – ADULTERY OR ILLICIT INTERCOURSE”; OF THE RIVERTON MUNICIPAL CODE AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF RIVERTON, FREMONT COUNTY, WYOMING:

Section 1. Section 9.04.050: Harass or interfere with any dog used by the police department of the Code of Laws of the City of Riverton is hereby repealed.

Section 2. Section 9.08.050: Unlawful to assemble of the Code of Laws of the City of Riverton is hereby repealed.

Section 3. Section 9.08.060: Unlawful to collect in crowds of the Code of Laws of the City of Riverton is hereby repealed.

Section 4. Section 9.08.120: Secret stalls, etc – Prohibited in certain establishments of the Code of Laws of the City of Riverton is hereby repealed.

Section 5. Section 9.08.170: Solicitation of fornication – Adultery or illicit intercourse of the Code of Laws of the City of Riverton is hereby repealed.

Section 6. Section 9.08.040: Unlawful assemblies is hereby amended to read as follows:

9.08.040 Unlawful assemblies.

~~Each and every one of~~ *It is unlawful for* any two or more persons ~~who shall come~~ *to assemble* together in the city for the purpose of doing any unlawful act with force or violence against the property of the city or against the person or property of another, or against the peace or to the terror of others, or who, being together, shall do any act or make any movement or preparation therefore;. *Anyone who participates in the aforesaid acts* shall be deemed guilty of a misdemeanor. (Prior code § 16-75)

Section 7. This ordinance shall take effect from and after its adoption and publication as required by law and the ordinances of the City of Riverton.
