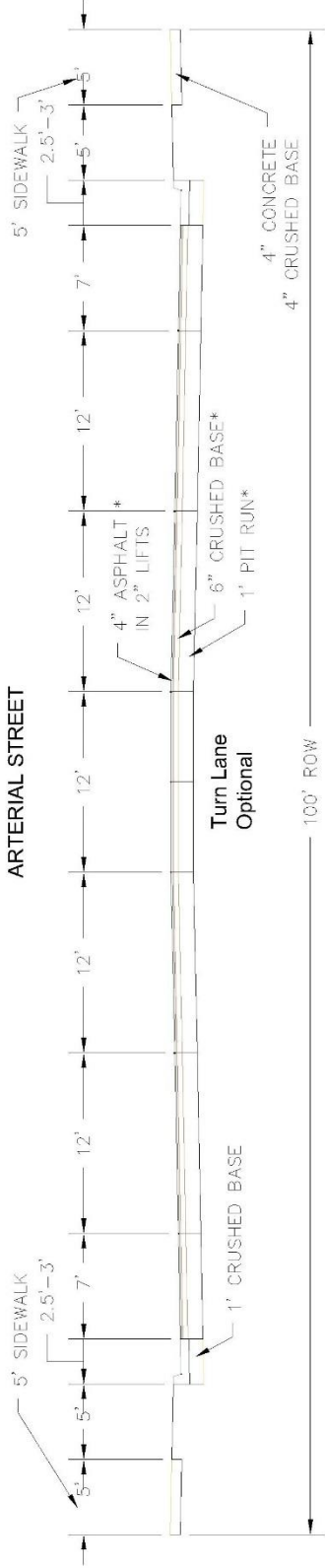
BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF RIVERTON, FREMONT COUNTY, WYOMING:

Section 1.

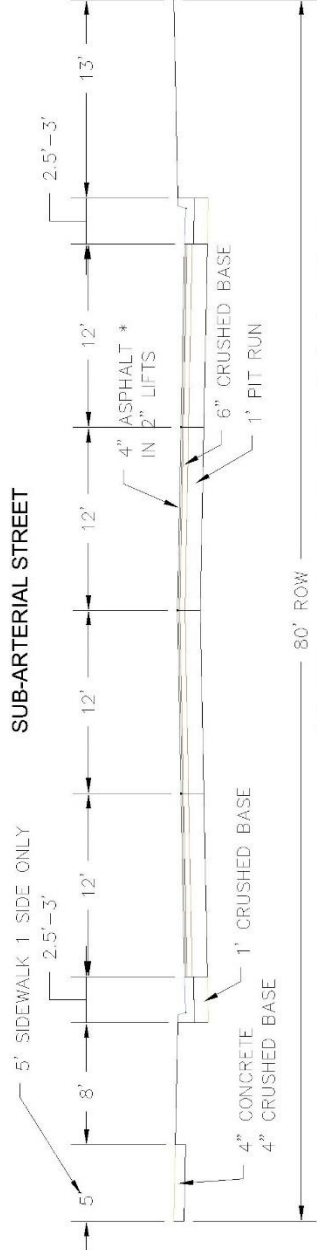
Chapter 16.16, Section 16.16.020(N) of the Municipal Code for the City of Riverton is hereby added to read as follows:
