

RESOLUTION NO. 1300

A RESOLUTION ESTABLISHING THE AMOUNT OF FEES FOR CERTAIN SERVICES AND BUILDING PERMITS WITHIN THE CITY OF RIVERTON, WYOMING.

WHEREAS, section 15.04.030 of the Riverton Municipal Code requires that the City Council, by resolution, establish valuations and fees for certain services and building permits within the corporate limits; and

WHEREAS, the Community Development Department recommends the same;

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Riverton, Wyoming, hereby declares that certain service and permit fees will be as follows:

<u>CATEGORY</u>	<u>RATE</u>
1. <u>International Building Code -</u>	
A. New Commercial Construction including warehouses	\$0.51 per square foot building area (includes building and all building systems) **
B. Storage units, pole barns, post frame, detached garage, deck additions, carports, similar structures.	\$0.12 per square foot of building area (includes building and all building systems) \$30.00 minimum.**
2. <u>International Residential Code -</u>	
A. New Residential Construction, Manufactured Home Construction (IRC or HUD Standard), with permanent foundation, accessory buildings, additions, decks, attached garages.	\$0.40 per square foot of building area (includes building and all building systems). **
B. Storage units, pole barns, post frame, detached garage, deck additions, carports, similar structures.	\$0.12 per square foot of building area (includes building and all building systems) \$30.00 minimum.**
3. <u>International Building Code/ International Residential Code/Hud Standard - (Alterations)</u>	
A. Alterations per square footage	\$50.00 minimum \$0.40 per square foot of alteration area
B. Equipment/material including labor	1% of contract amount
1. Siding, soffit, fascia & gutter	\$25.00 minimum
2. Electrical Service Upgrade (residential)	\$50.00 minimum
3. Electrical Alteration	\$25.00 minimum
4. Mechanical (Equipment Replacement)	\$50.00 minimum
5. Plumbing Alteration	\$25.00 minimum
6. Water Heater Replacement (residential)	\$25.00 minimum
7. Gas Piping Test	\$25.00 per test or trip
8. Sewer Replacement	\$50.00
C. Demolitions	\$0.12 per square foot
D. Relocation of structure	\$0.12 per square foot
E. Window/Door replacement (no structural alteration) (with structural alteration)	Permit required, no fee \$50.00 minimum
4. <u>Reroofing permits -</u>	
Residential Reroof (area >100 sq. ft.)	\$49.00
Commercial Reroof	1% of contract amount
5. <u>Communication Facilities - cell buildings/towers, etc.</u>	\$321.00
6. <u>Mobile Home (HUD Standard) - Park Sets</u>	
A. Single width unit	\$77.00
B. Multiple width unit	\$130.00
7. <u>Signs</u>	\$0.51 per square foot of sign face area or \$37.00 minimum



| (To include Preparation of notification list, Preparation of Notification letters, and Newspaper meeting advertisement) | |

| 17. <u>Plat Review</u> | |
| (Preliminary and final plats included) | The greater of \$150.00 or \$10 per lot,
up to a maximum fee of \$1000.00 |

| 18. <u>Call Back Fee</u> – Inspector called and site not ready | \$50.00 |

**For the purpose of determining building fees, "building area" is defined as the total floor area including all floor levels within the exterior walls, covered patios, attached garages, porches, and decks. "Alteration area" is defined as the total floor area that is collectively part of the remodel, renovation, room addition, etc. All calculated fees shall be rounded up to the nearest whole dollar.

BE IT FURTHER RESOLVED that this Resolution becomes effective immediately upon adoption.
