Minutes of the
Special Meeting/Council Work Session
Held June 10, 2014
6:30 PM

A Work Session of the Riverton City Council was held on the above date and time, duly convened by Mayor Pro-tem Mary Ellen Christensen at 7:00 p.m. City Council Members present were Rich Gard, Martin Cannan, Mary Ellen Christensen, Jonathan Faubion, and Kyle Larson. Council Member Cannan led the Pledge of Allegiance.

Riverton Regional Airport Grant Agreement – AIP 38 Reimbursable Agreement for Localizer – Council Member Faubion moved, seconded by Council Member Gard to approve the AIP 38 Grant Agreement Application. Motion passed unanimously.

Convene into Work Session – Airport Operations Report – Council Member Faubion moved, seconded by Council Member Larson to adjourn the Special Meeting and convene into the Work Session at 7:16 p.m. Motion passed unanimously. Milan Vinich gave a brief overview of the Airport operations for the Riverton Regional Airport.
