

ENROLLED ORDINANCE NO. 15-008

AN ORDINANCE AMENDING TITLE 9 “PUBLIC PEACE, MORALS AND WELFARE” REVISING CHAPTER 9.08 “OFFENSES AGAINST PUBLIC PEACE AND DECENCY” REPEALING SECTION 9.08.020 “CITY PARKS-CURFEW” AS WELL AS CHAPTER 9.16 “OFFENSES BY OR AGAINST MINORS”, REPEALING SECTION 9.16.020(B) “CURFEW”.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF RIVERTON, FREMONT COUNTY, WYOMING:

Section 1.

Title 9 is hereby amended to read as follows:

Chapter 9.08 OFFENSES AGAINST PUBLIC PEACE AND DECENCY

Section 9.08.020 City parks—Curfew.

~~It is unlawful for any person to be or remain in any city park of the city at night after the hours of twelve midnight until six a.m. (Ord. 98-007 § 19, 1998; prior code § 16-70) Repealed (for City parks – curfew see RMC Section 12.24.010).~~

Chapter 9.16 OFFENSES BY OR AGAINST MINORS

Section 9.16.020 – Curfew.

A. It is unlawful for any person under the age of eighteen (18) years to be or remain in or upon any of the streets, alleys or public places in the city at night after the hours of twelve midnight until six a.m. unless such person is accompanied by a parent, guardian or other person having legal custody of such minor, or unless such minor is in the performance of an errand or duty directed by such parent, guardian or other person having the care and custody of the minor, or unless the minor’s employment makes it necessary to be upon the streets, alleys or other places during the nighttime after such specified hours.

~~B. It is unlawful for any person to be or remain in any city park of the city at night after the hour of twelve midnight until six a.m. Repealed (for park curfew restrictions see RMC Section 12.24.010)~~

C. It is unlawful for any person, having legal care and custody of any child under eighteen (18) years of age to allow or permit such child to violate this section.

D. No child or minor person arrested under the provisions of this section shall be placed in confinement until his or her parent or guardian shall have been notified or a reasonable attempt made to contact them of such an arrest. (Ord. 06-016 § 1, 2006; Ord. 98-007 § 50, 1998; prior code § 16-105)

Section 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 3. This ordinance shall take effect from its adoption and publication as required by law and the ordinances of the City of Riverton.
